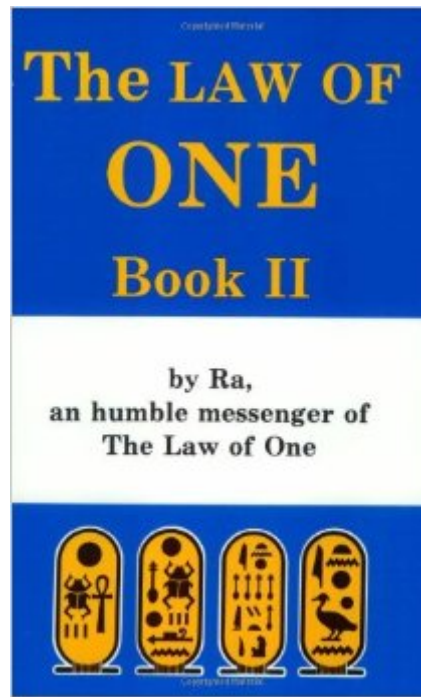

This book continues where book 1 stopped. In book 1, the questioner (an ufologist with a broad knowledge base) tends to lean more to retrieving information regarding the history/setup of Creation and where earth's/e.t. beings tie in. But instead of 'Ra' stating his knowledge, its intention is to be 'an humble messenger of the law of one'. Here the 'Free will' is of most importance, infringing on this wouldn't be according to the LoO. 'Ra' sometimes addresses the relative unimportance of details regarding beings in our 'current reality', hoping that we are interested in (thus querying) details on the laws of Creation (and its ways). Then in the 1st session of book 2 the Questioner actually states: "This session I thought we could start Book Two of THE LAW OF ONE, which will focus on what we consider to be the only important aspect of our being.. 'Don't get me wrong.. Since the questioner is an ufologist he doesn't stop trying to comprehend the implications.. These books really

excel in their format!The question is asked, then 'Ra' provides an answer. Then if the answer is too 'cryptic/difficult to comprehend' for him the questioner just acknowledges this and reformats the question.
