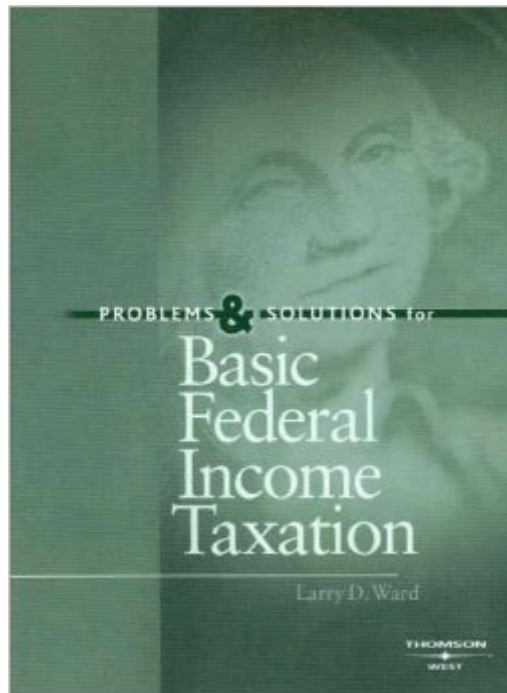

This book provides many practice problems for a Federal Income Tax class. The explanations are concise and very helpful in understanding the material. I found this book to be invaluable in studying Federal Income Tax and highly recommend it.
